## 1. Background

## **Overview of IPPF**

Headquartered in Nairobi, Kenya, IPPFARO delivers its critical missions with the support and leadership of 32 Member Associations (MAs), 7 Collaborative Partners, youth advocates, staff, and a network of dedicated volunteers who provide high quality, youth focused and gender sensitive services to those who are most vulnerable and marginalised. ## Overview of the engagement

IPPF is committed to advocating for the SRHR of all. Yet a multitude of barriers still exist resulting in shocking data on health outcomes: 220 million women who want to avoid pregnancy do not have access to modern contraception; 25 million have an unsafe abortion every year; and one in three experience sexual violence at some point in their lives.

Governments worldwide have committed to international and regional commitments towards delivering universal access to sexual and reproductive health and rights. However, these aspirations are far from being met and sustained multilevel and multipronged advocacy is required if they are to be translated into urgent action.

IPPFAR in collaboration with the Guttmacher Institute, is implementing the Global Policy Project which aims to advance SRHR, and the popularisation and adoption of the <u>Guttmacher-Lancet Commission's</u> (<u>GLC</u>) recommendations on <u>SRHR</u> in regional and national policy instruments.

# 2. Purpose

IPPFAR is seeking to recruit a short-term consultant(s) / consulting firm to undertake an advocacy documentation exercise in **Kenya**.

# 3. Roles and Responsibilities

This will include/involve:

- Conducting a desk review of existing national policies and linked advocacy process in-country with a view of providing a brief contextual analysis;
- Working with IPPFAR's collaborative partner in Kenya to understand and document their roles in national advocacy processes and identify key informants/interviewees/partners with whom they work.
- Conducting interviews with selected national civil society organisations and local partners, political leadership as/when necessary and appropriate, with the aim of collecting information on a specific advocacy intervention in the country (already identified).
- Writing a detailed narrative description of the advocacy intervention and process, based on the information collected from national partners and other interviewees.

#### 4. Timeline

The assignment is expected to take a maximum of 6 days within the period 17/April/2023 to 02/May/2023

#### 5. Milestones and deliverables

Key deliverables and the timeline will be discussed and agreed with the selected consultant.

- Understanding of and a commitment to safeguarding including child protection, in a local and international context.

#### Location

The location is virtual, but a candidate based in Kenya would be desirable so as to be able to conduct face-to-face meetings where possible.
